How do I sign up to judge?

DECA has two types of events that compete on Thursday:

Business Operations Research Events

Judges will evaluate a presentation regarding marketing research or a business plan that the student team has developed.

Project Management Events

Judges will evaluate a presentation where the student team has used their project management skills to initiate, plan, execute, monitor, control, and close a project.

Thursday

Judges arrive for orientation by 1:00 p.m.
Judging will be completed by 7:00 p.m.
Lunch will be provided.

Individual and Team Events

Judges take part in a role-playing situation to evaluate how well students demonstrate their skills in marketing and management. In these role-play events, students are required to accomplish a task or solve a problem by demonstrating an effective, efficient, and spontaneous plan of action.

Friday Morning

Judges arrive for orientation by 8:30 a.m.
Judging will be completed by 1:00 p.m.
Lunch will be provided.

OR

Friday Afternoon

Judges arrive for orientation by 12:00 p.m.
Judging will be completed by 5:00 p.m.
Lunch will be provided.

All judging will be at Huntington Place (formerly Cobo Center) in Detroit, Michigan.
